# THE MADHYA PRADESH NIJI VISHWAVIDYALAYA (STHAPANA AVAM SANCHALAN) SANSHODHAN VIDHEYAK, 2015

# A Bill further to amend the Madhya Pradesh Niji Vishwavidyalaya (Sthapana Avam Sanchalan) Adhiniyam, 2007.

Be it enacted by the Madhya Pradesh Legislature in the sixty-sixth year of the Republic of India as follows:—

Short title.

1. This Act may be called the Madhya Pradesh Niji Vishwavidyalaya (Sthapana Avam Sanchalan) Sanshodhan Adhiniyam, 2015.

Amendment of Schedule.

2. In the Schedule to the Madhya Pradesh Niji Vishwavidyalaya (Sthapana Avam Sanchalan) Adhiniyam, 2007 (No. 17 of 2007) after serial number 15 and entries relating thereto, the following serial numbers and entries relating thereto shall be inserted, namely:—

#### STATEMENT OF OBJECTS AND REASONS

In Section 5 of the Madhya Pradesh Niji Vishwavidyalaya (Sthapana Avam Sanchalan) Adhiniyam, 2007 (No. 17 of 2007), it is provided that the Regulatory Commission constituted under the Act shall evaluate the proposal of establishment or Private University in the State. In the light of the said provision, the Regulatory Commission has recommended to establish the Private Universities, namely, P. K. University Shivpuri, Mandsaur University, Mandsaur and Medi-Caps University, Indore. In the light of Section 6 of said Act, the State Government has issued a letter of intent to the sponsoring body of the Universities, with regard to the establishment of the said Universities. Section 9 of the said Act provides that after being satisfied on considering the report submitted by the Regulatory Commission, Private Universities shall be established by incorporating the name and description thereof in the Schedule to the said Act.

3. Hence this Bill.

With reference to your letter no MGU/REG/2016/03 dated 21.01.2016 on the subject cited above. I am directed to inform you that the UGC has received the (Act No. 10 of 2015) of the State Legislature of Madhya Pradesh wherein Medi- Caps University, A.B.Road, Pigdamber, Rau, Indore- 453331, Madhya Pradesh has been established as a Private University vide Notification No. 16214-Vi.S.Vidhan-2015 dated 22.07.2015. In view of the establishment of the Medi- Caps University, A.B.Road, Pigdamber, Rau, Indore- 453331, Madhya Pradesh by State Act, the name of the University has been included in the list maintained by the UGC on its website <a href="https://www.ugc.ac.in">www.ugc.ac.in</a>.

- 1. The inclusion of the name of the University in the list of Universities maintained by the UGC does not by itself allow the University to make admissions in its programmes. This may be done only after creation of required academic and physical infrastructure facilities, including library, laboratories and appointment of teaching and supporting staff as per the norms and standards laid down by the UGC and Statutory Council(s) concerned.
- 2. The University is now requested to submit detailed information in the enclosed format (Annexure-I) (soft copy as well as hard copy) along with supporting documents duly attested by the Registrar of the University within a period of 3 months from the receipt of this letter. This format along with appendices is also available on the UGC website <a href="https://www.ugc.ac.in">www.ugc.ac.in</a>
- 3. After receipt of the Information in the above mentioned format, the following procedure would be adopted by the UGC for inspection of the University:-
- (a) The information received from the University in the prescribed format would be posted on the UGC website within 10 days of the receipt of the information (Annexure-I). Comments would be invited from the general public within 1 month thereafter about the information submitted by the University The same information (Annexure-I) shall also be posted by the University on its website immediately. The comments received from the general public would be placed before the visiting UGC Expert Committee for perusal.
- (b) An Expert Committee would be constituted by the UGC to ascertain whether the University fulfils the criteria in terms of programmes, faculty, infrastructural facilities, financial viability, etc. as laid down criteria in terms of programmes, faculty, infrastructural facilities, financial viability, etc. as laid down from time to time by the UGC and other concerned statutory bodies such as AICTE, BCI, MCI, DCI, INC, NCTE, PCI, etc.
- (c) The UGC Expert Committee would visit the University within 3 months of the receipt of the information (Annexure-I) for on the spot assessment of infrastructure and other facilities available with the University. The report prepared by the UGC Expert Committee would be sent to the University within 2 weeks of the completion of the visit for comments.
- (d) The University may respond to the report within a period of two weeks after its receipt. After receipt of comments from the University, the report and comments from the University, if any, would be placed before the Commission for consideration.

#### STATUTE - 1

## Short Title, Commencement and the Jurisdiction

- (a) The "Statutes" means the Statutes of the MEDI-CAPS UNIVERSITY at Indore, Madhya Pradesh. Hereafter, the University means Medi-Caps University.
- (b) These Statutes shall come into force with effect from the date of the notification in the State Government Gazette.
- (c) These Statutes are prepared in the light of the provisions of the Madhya Pradesh Niji Vishwavidyalaya (Sthapana Avam Sanchalan) Adhinium 2007 and the amendments thereafter. If there be any difference in the provisions of the Act, Statutes, Ordinances and Rules and Regulations, the provisions of the Act shall prevail.
- (d) Nothing in these Statutes shall debar the University from amending these Statutes and / or providing subsequent Statues according to the provision of Section 26 of the Act. The amended / subsequent statues, if any shall be applicable with immediate or retrospective or prospective effect, from such a date as prescribed in the notification.

## The Jurisdiction for Legal Matters

All matters pertaining to any act / law shall be the subject of the jurisdiction of Indore, Madhya Pradesh.
